Prince of Peace Preschool admits students of any race, color, or national or ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. TUITION: Tuition is paid in nine equal payments and the **first tuition payment is due when you register** unless other arrangements have been made with the Director. The September tuition payment and the Registration Fee payment will ensure a place for your child in the Preschool. **Late start enrollees will be required to pay the registration fee and the first month's tuition which are non-refundable.**

Tuition is due one month in advance for the remainder of the Preschool year. For example, the December tuition will be due on or before November 1st. Payments are late after the 10th of each month and a \$10.00 late charge is added after the 15th.

REFUNDS: September's tuition will be refunded if the Prince of Peace Preschool is notified in writing prior to August 1, 2010, of your need to withdraw from the program.

POLICY FOR WITHDRAWALS: In order to avoid tuition charges for a given month, written notification of your intent to withdraw must have been received by the preschool office prior to the date that tuition became payable for that month. (For example, the March payment would not become payable if the office receives such notification on or before February 1st.)

ENROLLMENT FORMS: Health and immunization forms and emergency care release forms required by the State of Kansas licensing agency and our Preschool Board of Directors **must be completed and returned to the Preschool office before your child may attend classes.**
